### 1/2/19 Appointment with Dr. Barton

- I spoke to Dr. Weiss about my appointment with Dr. Barton
- Referred by Dr. Barton to specialist at LSU's university hospital.
- For epilepsy long-term overnight/etc monitoring.
  - 1/10/19 referred doctor is still unknown.
  - Don't have a name.
  - Don't have a set/made appointment date/time.
- Dr. Weiss said that if this new, upcoming neurologist, wanted to take me off my medication for the testing. That the doctor could.
  - Dr. Weiss encouraged me to inform the new doctor that he's more than welcome to speak to her.
  - Its ok for me to be taken off my currently prescribed Adderall 30mg 3/day + Wellbutrin 1/day.
- Told Dr. Weiss how this is all for making sure that these falls, lapses of consciousness?, blackouts?, tremors, unconfirmed seizures, etc. Is all confirmed.
  - Differentiated from my narcolepsy, and any other underlying conditions.
  - I.e. the already diagnosed "seizure syndrome"
  - Low-tolerance/low-threshold for seizures
  - Medications lower the tolerance even further.

### New neurologist notes

- Dr. Weiss mentioned that she had spoken to other peers (neurologists) about me.

- To find me another one who would be comfortable/experienced/could treat my narcolepsy. See prescribing me my 40mg Adderall 3/day.
- Other peers said that "Sleep Medicine Doctors" were the specialists for me to focus on for narcolepsy treatment. They claimed that they, neurologists, didn't really treat my condition at all anymore. That this was the best practice industry normative and that it was heading more in that direction.
- Found/List of discussed Sleep Medicine Doctors:
  - Dr. Shamolon
    - According to Dr. Weiss he is not affiliated with Ochsner.
    - Did research on him (name) 1/10/19 couldn't find anything
    - Dr. Weiss said she'd try to contact him too before my next appointment w/her.
