- Discussed the previous treatments of:
- Neurontin (neuropathy)
- Botox Injections (cluster migraine headaches)
- Neurological meds that lowered seizure threshold in high school
- Topamax
- Butalbital
 - I stated it was 325 mg of "aspirin" // 5 mg Codine
 - Given to treat pain secondary to the cluster migraine headaches
 - How it genuinely did help.
 - When I had the migraine, this medication was key. To lessening the burden placed on my body (physiologically).
 - By me taking at night/evening post-school day.
 - Falling asleep b/c of it, knocks out.
 - And then are lessened effects of burden on me.
 - However, noted that it did/does lower the efficacy of my Stimulant Therapy
 - How that is a huge issue.
 - le even though I was on the lowest dosage of Butalbital.
 - Only took in the least frequent intervals (3 days).
 - To stay off the Barbiturate induced withdrawal.
 - Which the withdrawal from it 2016-03 or 2016-04.
 - Was in fact extremely difficult and inhibited me from going to school. For period no less than 30 days.
 - As, the withdrawal specifically, was extremely taxing on me b/c the Narcolepsy.

- Note: Was more difficult than the Interferon withdrawal period.
- Spoke of some other things relating to neurological profile over the years. Etc.
 - o le recent seizure (grand mal) 2020-02 or 2020-03
 - Seizure study admittance to hospital, or lack thereof.
 - Ie UMC does not have their facility up and running.
 - She said they would be trying to get it up and running.
 - That Children's hospital does have their facility up and running.
 - That she would have to go to Children's in the 1 or 2 times a year. She goes there.
 - To get the orders entered CHNO system.
 - B/c then I could get done there.
 - She wanted to speak to Dr. Olejniczak 1st though.
 - To coordinate on seizure epilepsy testing/this hospital admittance testing.
 - Also, she noted that the VA hospital does in fact have their facility up and running.
 - Which is what Dr. Olejniczak mentioned. Last time I saw him.
 - So, maybe I'll end up getting it through them.
- We spoke about the Adderall 40mg in their system.
 - She noted that it does in fact have "two"? listings for my current prescription.
 - Within UMC's system
 - And, that one of those listings has the 40 mg listed as a note.
 - On the 30 mg listing itself.
 - Note:
 - Had the nurse enter this in person.
 - o 2020-08-19 8:15 am
 - ENT
 - o Dr. Pelaez appt
 - For hearing testing
 - Noted: Some hearing damage by Audiologist

- Seeing as how I mentioned to him, how my Mother would (2016).
- Yell in my ear as I was immobilized in a state of sleep paralysis.
- Which she tried to change but could not
- As she said it required the original physician to edit completely.

Note:

- Dr. Monica Noya Santana also could not fix this.
- It seemed as though it was an IT issue.
- Note to self:
 - o Have Dr. Santana try again
 - o On 2020-09-08 phone appointment.
 - To change the Adderall fr 30 mg
 - To 40 mg
 - o Instead of current "just noted"
 - Within one of the TWO listings within the UMC system.
 - Under their medications and such.
- Discussed: Neuropathy + Seizures
 - o As in:
 - o Temperature within the last winter fall/winter/spring 2020.
 - With no heat properly.
 - No ability to go downstairs to eat. B/c constant issues with the freezing cold.
 - o B/c heat was not properly triggered to come on.
 - See temperature data project all the rooms, and during that timeframe.
 - o As in:
 - Temperature surrounding last (2019) late spring/summer/early fall.
 - Wherein air conditioning was set way to cold.
 - Forced by my mother's delusions.
 - Plus, my ignorance of our home's:
 - Airflow
 - Temperature issues.
 - Knowledge gained only through temperature data project.
 - o Gaining a heater/heater in my room.
 - Circa 2019-12-00

- Helped a lot.
 - Even though it does in fact induce cluster migraine headaches.
 - At sometimes.
 - If it seems to overwork itself.
 - Otherwise it is fine.
 - Also, rooms humidity content likely impacts the heaters strain on itself.
 - o THIS is large factor in its function.
- Got to frequently low 60s f.
- Got to frequently mid 55s f
- During this period.
 - Late spring (Late April 2019 // Air Installation)
 - Summer (2019)
 - Early-Fall to Mid-Fall (2019)
- o Spoke of all this in relation to my neuropathy.
 - Etc.

- -- Instead of just treating pain secondary to cause of migraines.
- --- As was "exhausted" as an option back in 2016~. B/c of my Narcolepsy.
- Spoke to Doctor briefly of new injections.
- -- Few I recognized as (from FDA) are current trials.
- -- Doctor will get back to me after "in-depth research". On availability of these.
- -- I believe likely one would. As my insurance sent me info about it in the mail.
